MEETING THE NEEDS OF CHILDREN & FAMILIES IN HERTFORDSHIRE **HANDBOOK**

Hertfordshire Children's Trust Partnership (HCTP) has made a number of changes to improve its arrangements for ensuring that vulnerable children and young people receive the right response at the right time. As part of this work, we have recently completed a review of the thresholds for accessing targeted and specialist services, and finalised a revised version of the Meeting the Needs of Children and Families in Hertfordshire handbook.

The handbook, which has been signed off by the Hertfordshire Children's Trust Partnership and Hertfordshire Safeguarding Children's Board, sets out clear thresholds which will support practitioners in making decisions on how best to respond to the needs of children and families. It is expected that all agencies in the county will work to the thresholds as set out in this handbook. It is therefore important that the children's workforce in Hertfordshire have a clear understanding of the threshold guidance in their work with children and families, and that it is consistently used across the county.

Printed copies of the Meeting the Needs of Children and Families in Hertfordshire handbook are being distributed to a range of services in the county, including schools, health, GP practices, police, the voluntary and community sector, CSF services and district/borough councils etc. Services may request additional copies of the handbook by emailing meetingtheneeds@hertscc.gov.uk. The handbook is also available online at www.hertsdirect.org/integratedpractice.

An interim services contact list has been developed to aid signposting to other services. Please note that this is not a comprehensive directory of services. It is only an interim solution as we work towards developing a more comprehensive Family Services Directory. This contact list will be updated regularly. The interim services contact list is available online at www.hertsdirect.org/integratedpractice. You will also find links on this page, to other specific service directories, such as 'Numbers U Need', a directory of services for young people and the 'Ultimate Guide' which is a directory of services for young parents.

Additional support and guidance will be available through District Integrated Practice Networks and District Partnership Teams. The teams' contact details for Integrated Practice are on the back page of the handbook. 2011 Census

The national Census takes place every ten years and is a count of every person living in the UK. The next Census will take place on 27th March 2011.

The Census matters to everyone as its population counts are used to allocate money to Hertfordshire for local services in the next 10 years. These include health, the police, schools and colleges, housing, roads and public transport and other services provided by both the County and District Councils' such as sports & leisure facilities. Businesses also use Census information to help plan where to provide jobs and facilities such as shops.

The Office for National to plan for the Census and to encourage and help everyone to be counted.

The Census forms will start landing on doorsteps in the middle of March 2011, you'll recognize it by the purple Census logo at the top of the form. Once you've completed the form, place it back in the envelope that's provided and pop it in a postbox. For the first time it will be possible to complete the Census on-line, using the unique code at the top of your form.

VETTING & BARRING

The government last week unveiled plans to scale back the vetting and barring scheme (VBS) and criminal records regime to common sense levels while ensuring vulnerable groups are appropriately protected.

Below is a summary of the reviews and recommendations.

The proposals include:

- the merging of the Criminal Records Bureau (CRB) and Independent Safeguarding Authority (ISA) to form a streamlined new body providing a proportionate barring and criminal records checking service;
- a large reduction of the number of positions requiring checks to just those working most closely and regularly with children and vulnerable adults;
- portability of criminal records checks between jobs to cut down on needless bureaucracy;
- an end to a requirement for those working or volunteering with vulnerable groups to register with the VBS and then be continuously monitored by the ISA; and
- stopping employers who knowingly request criminal records checks on individuals who are not entitled to them.

Vetting and barring Scheme Remodelling Review – Report and Recommendations

The VBS had been created to help safeguard children and vulnerable adults, following the Bichard Inquiry and was designed to check the records of those who wanted to work with vulnerable groups. In June 2010, ministers announced that the planned implementation of the VBS was to be halted, pending a thorough review.

The Safeguarding Vulnerable Groups Act 2006 sets out a framework for the scope and operation of the vetting and barring scheme. New primary legislation will amend this to scale back the scheme, in particular, through the abolition of the registration and monitoring requirements and the re-definition of the range of posts to which barring arrangements apply.

NEWS FROM THE HOSPITALS

The maternity services building at the Lister Hospital was handed over to the hospital Trust in November 2010. This will allow the hospital to use it for the existing programme of births whilst the existing buildings can be brought up to the new standard. It will not be until October/November 2011 before it can accept births from the QEII. There will be both a Consultant-led & Midwife-led ward in adjacent birthing areas, plus theatres and an expanded neonatal department on the ground floor. On the first floor there will be a new reception area and day assessment unit together with 2 improved hospital wards. The QEII's neonatal and gynaecology impatient services will move there at the same time.



Antenatal, postnatal & outpatient services will continue at the Lister, QEII & Hertford County Hospitals after the 2011 transfers. The East of England Strategic NHS Trust has been asked to review if a standalone midwife-led ward until could safely remain at the QEII site without any other support, as was tried at Hemel until withdrawn.

In Mid April 2011, the opening of the Lister SurgiCentre will mean that these changes will occur:

- The Essendon Eye Theatre will close with most work going to the SurgiCentre.
- On both sites there will be a reduction in elective impatient services with 23 hr & short stay orthopaedic work going to the SurgiCentre.
- The remaining day surgery from both sites will go to Queens Wing and Essendon Ward.
- All fractured hip surgery will go to the Princes Wing theatres.
- All remaining planned orthopaedic surgery will go to Princes Wing.
- All emergency trauma orthopaedic cases will be at the Lister.
- All of the Trust's emergency general surgery will be at the Lister.
- Dedicated plastics trauma theatre sessions at the Lister.

November 2011

- New Maternity unit fully open
- All inpatient obstetric & gynaecological surgical services brought together at Lister

Early 2014 will see the additional facilities at the Lister and that will mean they will:

- Allow the Trust to achieve best clinical practice & improve outcomes for patients. 1.
- 2. Create a critical mass of clinical & medical staff on one site, thus enabling the Trust to sustain a wider range of high quality services than would otherwise be possible, along with the introduction of new technologies.
- 3. Only means of maintaining viable 24/7 medical staffing rotas for all of the Trust's services, thus ensuring patients have faster access to doctors - especially at night & weekends.
- 4. Facilitate the modernisation of the Trust's clinical facilities, improving its attractiveness to patients at a time of an increasing choice of alternative options.
- 5. Improve the experience of patients & their relatives who access the services offered by the Trust
- 6. Enhance the Trust's ability to attract and retain high quality staff, whilst at the same time allowing for when acute care is provided in community settings.
